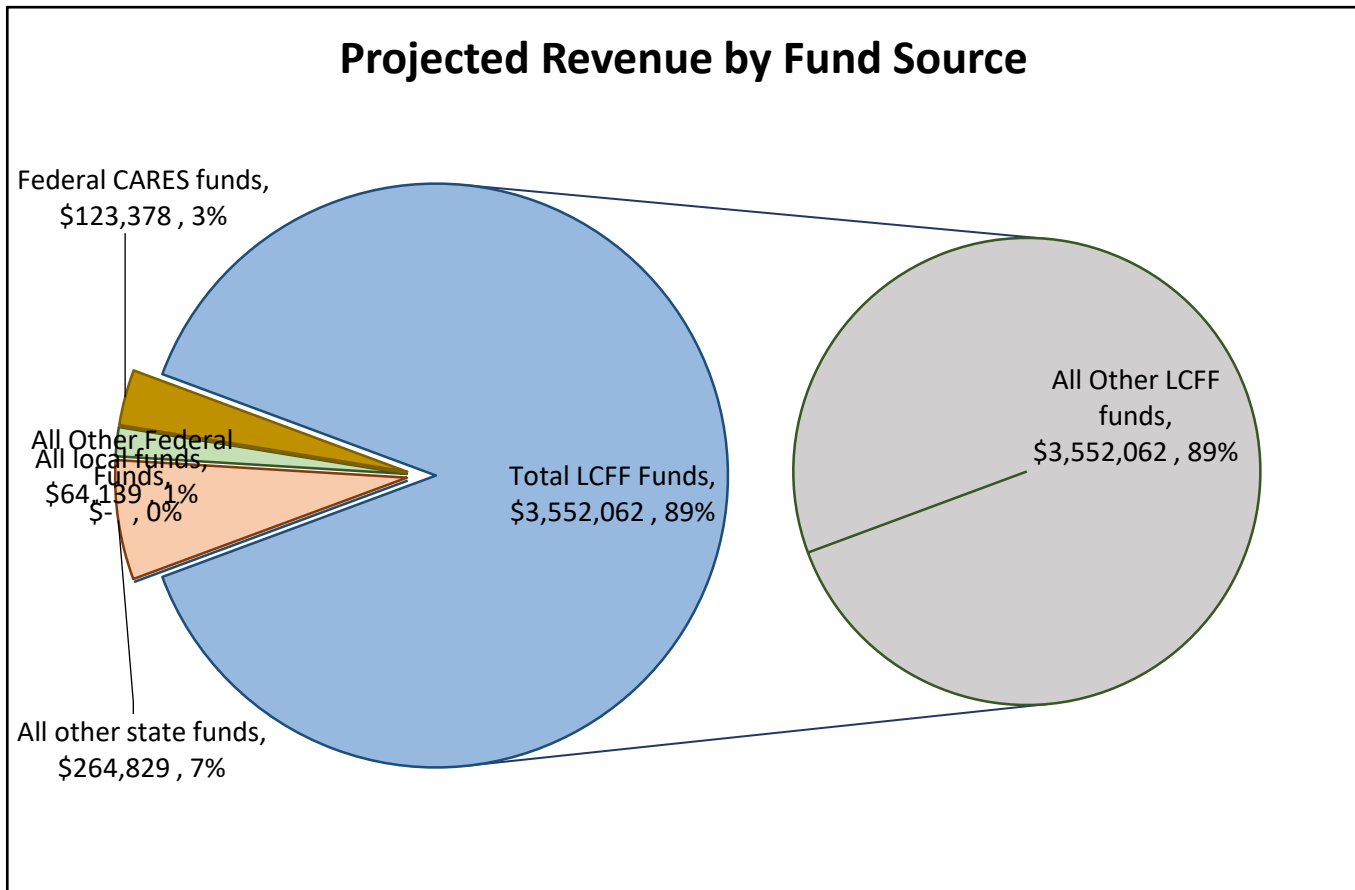

LCFF funds include a base level of funding for all LEAs and extra funding - called "supplemental and concentration" grants - to LEAs based on the enrollment of high needs students (foster youth, English learners, and low-income students).

Projected Revenue by Fund Source

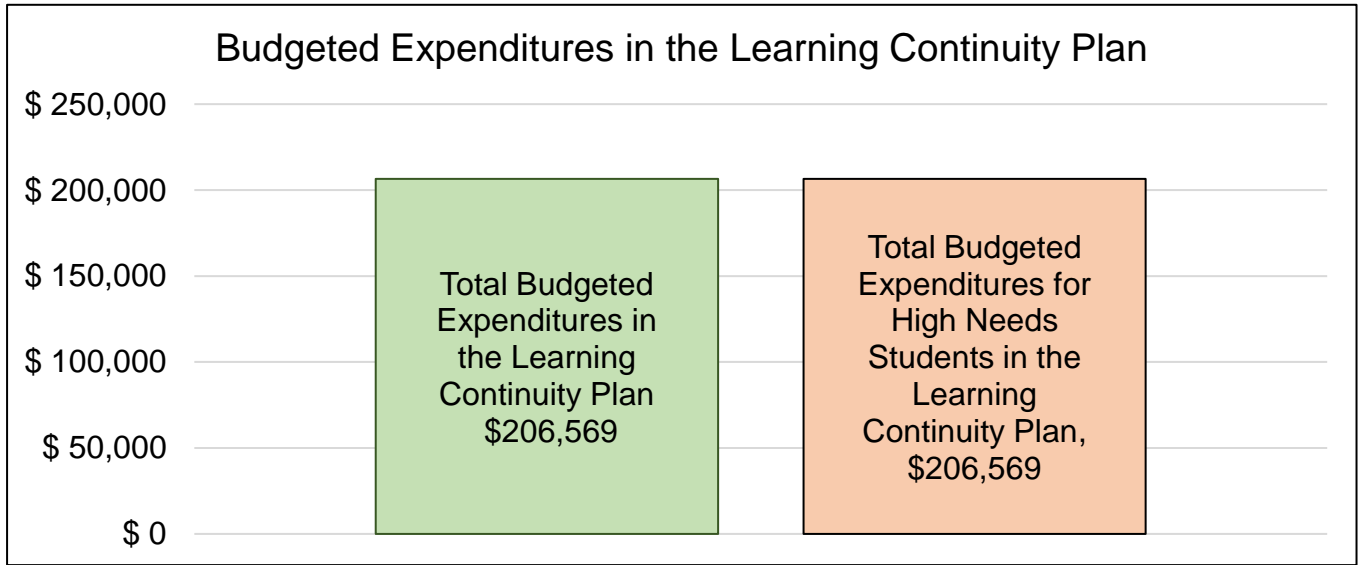


This chart shows the total general purpose revenue Morris E. Dailey Charter Elementary expects to receive in the coming year from all sources.

The total revenue projected for Morris E. Dailey Charter Elementary is \$4,004,408.00, of which \$3,552,062.00 is Local Control Funding Formula (LCFF) funds, \$264,829.00 is other state funds, \$64,139.00 is local funds, and \$123,378.00 is federal funds. Of the \$123,378.00 in federal funds, \$123,378.00 are federal CARES Act funds. Of the \$3,552,062.00 in LCFF Funds, \$0.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

This chart provides a quick summary of how much Morris E. Dailey Charter Elementary plans to spend for planned actions and services in the Learning Continuity Plan for 2020-2021 and how much of the total is tied to increasing or improving services for high needs students.

Morris E. Dailey Charter Elementary plans to spend \$3,876,217.00 for the 2020-2021 school year. Of that amount, \$206,569.00 is tied to actions/services in the Learning Continuity Plan and \$3,669,648.00 is not included in the Learning Continuity Plan. The budgeted expenditures that are not included in the Learning Continuity Plan will be used for the following:

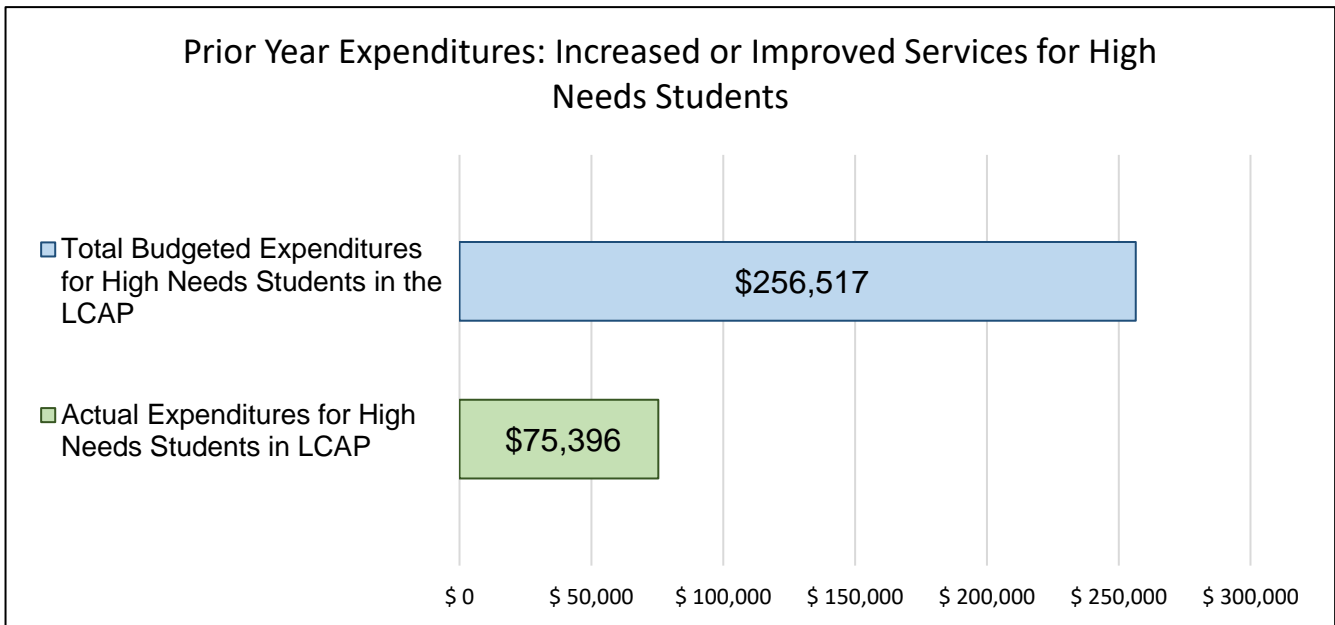
Classroom and administrative salaries, services and operating expenditures (travel/conferences, insurance, dues and memberships, rentals, leases, repairs, etc.)

Increased or Improved Services for High Needs Students in the Learning Continuity Plan for the 2020-2021 School Year

In 2020-2021, Morris E. Dailey Charter Elementary is projecting it will receive \$0.00 based on the enrollment of foster youth, English learner, and low-income students. Morris E. Update on Increased or Improved Services for High Needs Students in 2019-2020



This chart compares what Morris E. Dailey Charter Elementary budgeted in the 2019-20 LCAP for actions and services that contributed to increasing or improving services for high needs students with what Morris E. Dailey Charter Elementary actually spent on actions and services that contributed to increasing or improving services for high needs students in the 2019-20 school year.

In 2019-2020, Morris E. Dailey Charter Elementary's LCAP budgeted \$256,517.00 for planned actions to increase or improve services for high needs students. Morris E. Dailey Charter Elementary actually spent \$75,396.26 for actions to increase or improve services for high needs students in 2019-2020. The difference between the budgeted and actual expenditures of \$181,120.74 had the following impact on Morris E. Dailey Charter Elementary's ability to increase or improve services for high needs students:
